York County Library - Computer Use Policy Synopsis

Complete policy in English and Spanish is attached to this clipboard.

Rules of Use:

- All users, regardless of age, are expected to abide by this policy.
- The Internet enables access to materials that may be inaccurate, controversial, personally offensive to the viewer, illegal, or inappropriate for children. In spite of filtering software, users must exercise judgement in evaluating the validity and appropriateness of information so retrieved. York County Library cannot be held liable for the content of Internet sites.
- York County Library affirms the responsibility of parents to determine the appropriateness of Internet resources for their children. A parent, guardian, or legal caregiver, through signature, is responsible for access of children and young people under the age of 18. Children under 10 years of age must be accompanied by an adult who is 18 years of age or older and who, through signature, has agreed to the terms of this policy.
- Library staff will assist computer users in a manner consistent with other library services.
- All users of electronic information resources are expected to use these resources in a responsible manner.
- There is a one-hour time limit for the use of computers when other users are waiting in the Reference area and in the Branches and a two-hour time limit in the Technology Center.
- The library does not provide email accounts. Users may send, receive or download email using public computers. Internet transactions involving the use of credit cards are conducted strictly at the risk of the user.

Computer Users May Not:

- Damage or attempt to damage equipment; alter or attempt to alter software configurations;
- Attempt to gain unauthorized access to or cause disruption of the Library's computer system or any other computer system;
- Violate copyright laws or software licensing agreements;
- Install their own software programs on computers;
- Bookmark specific sites on Library computers;
- Display or send obscene (as defined by South Carolina Code of Laws 16-15-305) images, messages, or files;
- Violate local, state, or federal laws or regulations; or
- Engage in any activity that is deliberately and maliciously offensive, libelous, or slanderous.

Because the library is a public place, library staff has authority to end an Internet session when irresponsible or inappropriate behavior is displayed. Violations of this policy may result in loss of computer access and /or other library privileges.

Unlawful acts are subject to prosecution by local, state, and federal authorities.
